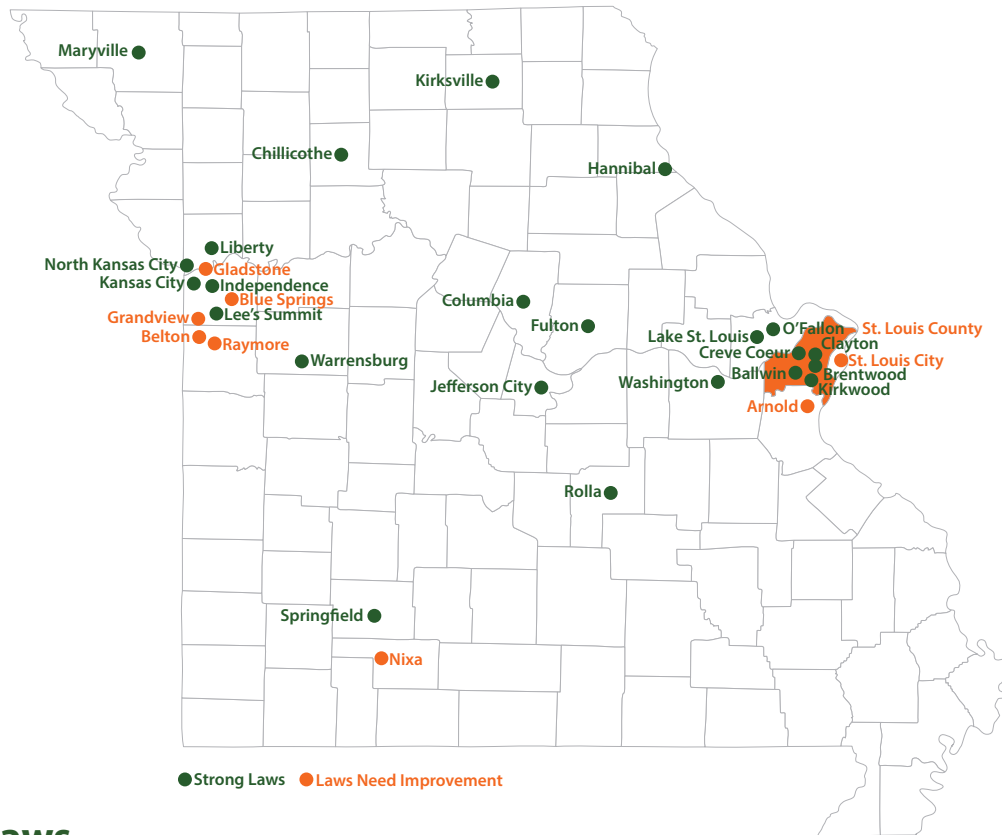




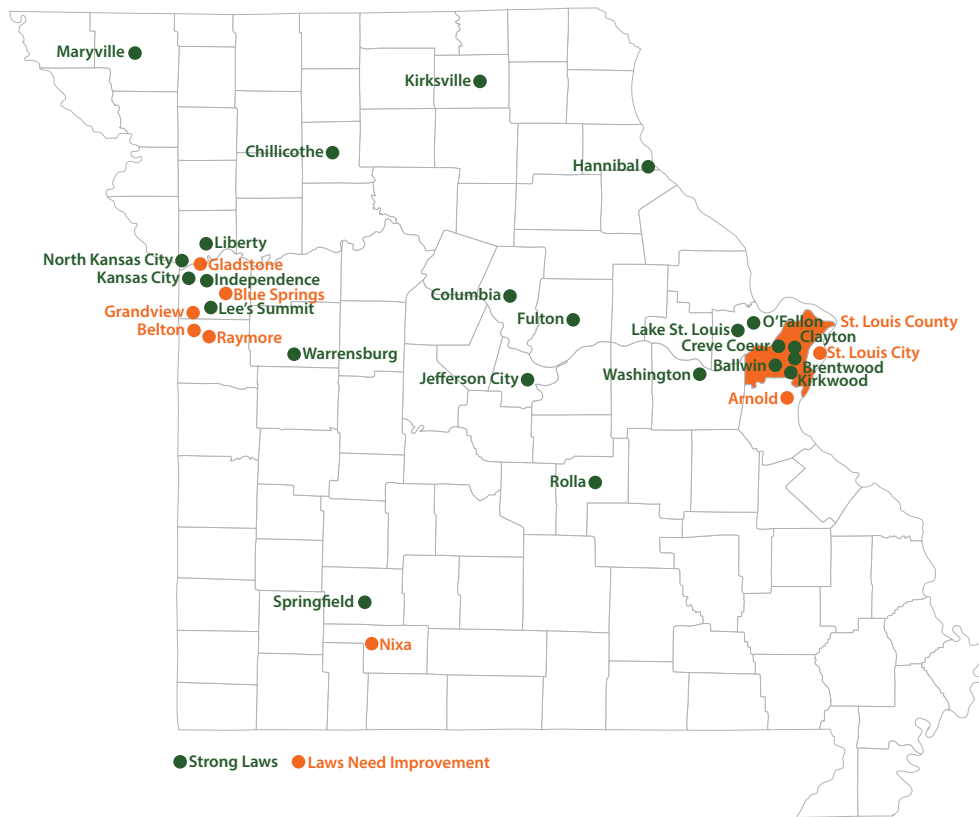
# Smokefree Laws in Missouri

## March 2013



### Strong Laws

- **Ballwin:** smokefree workplaces, restaurants, and freestanding bars (January 2006)
- **Brentwood:** smokefree workplaces, restaurants, and freestanding bars (January 2011)
- **Chillicothe:** smokefree restaurants and freestanding bars (January 2008)
- **Clayton:** smokefree restaurants and workplaces (no bars in Clayton via local statute) (July 2010)
- **Columbia:** smokefree restaurants and freestanding bars (January 2007)
- **Creve Coeur:** smokefree restaurants and freestanding bars (January 2011)
- **Fulton:** smokefree workplaces, restaurants, and freestanding bars (December 2010)
- **Hannibal:** smokefree workplaces, restaurants, and freestanding bars (July 2012)
- **Independence:** smokefree workplaces, restaurants, and freestanding bars (March 2007)
- **Jefferson City:** smokefree workplaces, restaurants, and freestanding bars (January 2011)
- **Kansas City:** smokefree workplaces, restaurants, and freestanding bars (June 2008)
- **Kirksville:** smokefree restaurants and freestanding bars (July 2007)
- **Kirkwood:** smokefree workplaces, restaurants, and freestanding bars (January 2010)
- **Lake Saint Louis:** smokefree workplaces, restaurants, and freestanding bars (September 2010)
- **Lee's Summit:** smokefree workplaces, restaurants, and freestanding bars (December 2006)
- **Liberty:** smokefree workplaces, restaurants, and freestanding bars (January 2010)
- **North Kansas City:** smokefree workplaces, restaurants, and freestanding bars (August 2008)
- **Maryville:** smokefree workplaces, restaurants, and freestanding bars (October 2010)
- **Lee's Summit:** smokefree workplaces, restaurants, and freestanding bars (June 2011)
- **Rolla:** smokefree workplaces, restaurants, and freestanding bars (effective January 2012)
- **Springfield:** smokefree workplaces, restaurants, and freestanding bars (June 2011)
- **Warrensburg:** smokefree workplaces, restaurants, and freestanding bars (November 2010)
- **Washington:** smokefree workplaces, restaurants, and freestanding bars (April 2013)



## Laws Needing Improvement

- **Arnold:** allows smoking in restaurants with ventilation, no restrictions on bars (November 2004)
- **Belton:** workplaces (January 2012); restaurants (January 2016)
- **Blue Springs:** exempts bars and many restaurants (May 2008)
- **Gladstone:** allows smoking in restaurants with fewer than 50 seats and no liquor license, pool halls, bowling alleys, and bars until their liquor licenses change ownership (February 2012)
- **Grandview:** smokefree workplaces and restaurants; freestanding bars are delayed until 2014 (January 2012)
- **Nixa:** smokefree restaurants in public spaces, smoking allowed in other areas (June 2007)
- **Raymore:** exempts bars and restaurants with attached bars are grandfathered (August 2008)
- **St. Louis City:** smokefree workplaces and restaurants; casinos and some bars (less than 2000 square feet) are exempted, bars will be smokefree in 2016; (January 2011)
- **St. Louis County:** smokefree workplaces and restaurants; casinos and some bars (based on liquor sales) are exempted (January 2011)
